Rte 90 to Rte 193 Kingsville exit, exit #235. Go south on Rte 193 2-3 miles to Plymouth-Gageville Rd. Turn right (west), go 1.9 miles to Maple Rd., go .3 miles to entrance on left. Fischer's Pine Lake Park.

From the South:

Rte 11 to Rte 167 east (right turn) to Brown Rd., 1.2 miles Turn left onto Brown Rd. Go 3.2 miles to Griggs Rd., (turn right). Go .8 miles to Maple Rd. (turn left). Go 2.8 miles to show site on the right. Fischer's Pine Lake Park.
